III. HAZARDS IDENTIFICATION

EMERGENCY OVERVIEW: Primary Route(s) of Entry: Eyes, Skin, Inhalation, Ingestion **POTENTIAL HEALTH EFFECTS:** Harmful if swallowed or absorbed through skin. Causes eye irritation. Avoid contact with skin, eyes, or clothing.

EYE: Causes eye irritation

SKIN: May cause skin irritation.

INGESTION: Harmful if swallowed.

MEDICAL CONDITIONS AGGRAVATED: No specific medical conditions are known which may be aggravated by exposure to active ingredient. Fertilizer portion may cause mild irritation to eyes and skin. Ingestion of large amounts may cause gastrointestinal disorder, nausea, vomiting and/or diarrhea.

POTENTIAL ENVIRONMENTAL HAZARDS: This product is highly toxic to aquatic invertebrates. Do not apply directly to water, or to areas where surface water is present or to intertidal areas below the mean high water mark. Do not contaminate water when disposing of equipment washwaters. This chemical demonstrates the properties and characteristics associated with chemicals detected in groundwater. The use of this chemical in areas where soils are permeable, particularly where the water table is shallow, may result in groundwater contamination.



EYES: Hold eye open and rinse slowly and gently with water for 15 - 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

SKIN: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15 – 20 minutes. Call a poison control center or doctor for treatment advice.

INHALATION: Move person to fresh air. If person is not breathing, all 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth if possible. Call a poison control center or doctor for further treatment advice.

INGESTION: Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give anything by mouth to an unconscious person.

EXPLOSION HAZARDS: Under fire conditions, toxic, corrosive fumes are emitted. Dispersion of fine dust in the air can form an explosive mixture.

FIRE FIGHTING PROCEDURES: Keep out of smoke. Cool exposed containers with water spray. Fight fire from upwind position. Use self-contained breathing equipment. Contain runoff to prevent entry into sewers or waterways. Equipment or materials involved in pesticide fires may become contaminated.

VI. ACCIDENTAL RELEASE MEASURES

RELEASE NOTES: If material is spilled keep unnecessary people away, isolate hazard area and deny entry. Avoid contact with spilled product or contaminated surfaces.

Avoid generating dust (a fine water spray mist, plastic film cove, or floor sweeping compound may be used if necessary). Avoid breathing dusts and skin contact. Use recommended protective equipment while carefully sweeping up spilled material. Place in covered container for reuse or disposal. Scrub contaminated area with soap and water. Rinse with water. Use dry absorbent material such as clay granules to absorb and collect wash solution for proper disposal. Contaminated soil may have to be removed and disposed. Do not allow material to enter streams, sewers, or other waterways.

VII. HANDLING AND STORAGE

GENERAL PROCEDURES: Handle and open container in a manner as to prevent spillage. Do not contaminate water, food, or feed by storage or disposal. Store in a cool, dry palace and in such a manner as to prevent cross contamination with other pesticides, fertilizers, food, and feed. Store in original container and out of reach of children, preferably in a locked storage are.
